# **Buller District Licensing Committee (BDLC)**

## Annual Report to the Alcohol Regulatory and Licensing Authority

## For the Period 01/07/18-30/06/19

#### 1. Overview of the BDLC workload

1.1 Structure and personnel

The Chairperson (or Deputy Chairperson) decides all uncontested applications on their own. A quorum for opposed applications is still maintained with the remaining committee members.

1.2 BDLC Meetings and Hearings

The Chairperson (or Deputy Chairperson) generally makes their decision on uncontested application on an as received basis.

There were two hearings held within the past year. One for a new Manager's Certificate which was declined. The other hearing was for a new off-licence (stand alone bottle store). The application drew a number of objections from the public, most of which had no standing, but were of concern to the general public mainly because they felt Westport did not need another bottle store. The applicant (who also has two bottle stores in other areas) and the application met the criteria under section 105 and the application was duly granted, though the licence has yet to be issued.

2. BDLC Initiatives

As the Chairperson is not resident in Westport, all of the 'on the paper decisions' are made using email as the method of correspondence. This has worked well and resulted in a faster turn-around of applications.

Reminders are sent to applicants of special licences for the previous Christmas/New year periods, and ANZAC day. This has meant that applicants for annual events during this period are well aware of the 20 working day timeframe for applications, and there were not any issues with late applications last year.

We encourage applicants for licences to make an appointment to discuss prior to lodgment or at time of lodgment of their application. This helps with receiving any outstanding information required in a timely manner.

Our aim is to process all uncontested applications within 30 working days. If this has not been achieved, the reason is usually of a resource availability nature. As FENZ have not been reporting on our applications for licences for approximately 2 years, we usually have to wait the full 15 day working period before an inspector's report can be finalized and sent to the DLC for a decision.

Special licences for funerals or funeral after functions held at licensed Clubs: By agreement with the DLC, Police and Community and Public Health, we do not require a "meeting" for these decisions, this is mostly due to time constraints as obviously the applicant cannot give 20 working day notice for a funeral function. We consider it an obligation to our community to provide this service. Both the decision and licence are standardly worded.

In 2017, application forms were reviewed by all three West Coast councils and updated to be used as a shared resource. This included additional information being requested so that inspectors can better report on the applications which will in turn result in better information provided to the DLC for them to consider when making decisions. Earlier this year, the application forms were reviewed again by all three councils, and some changes have been made to improve efficiencies.

#### 3.0 Local Alcohol Policy

There has been no further progress on a Buller Local Alcohol Policy to date. Though there are local alcohol ban areas in both Westport and Reefton.

#### 4.0 Current legislation

As per last year's comment, the new Act continues to bring out varied interpretation in discussions. The NZ Institute of Liquor Licensing Inspectors (NZILLI) is the main source for gaining information and resolution of issues but often also highlights further anomalies within the Act and the varying ways DLC's and inspectors are interpreting it.

The continuing requirement for Temporary Authority applications to be heard by a full committee and not just the Chairperson when no objections have been received remains an issue as there is usually pressure to get these out to allow new owners to commence operating. There does not appear to be any reason why unopposed applications cannot be dealt with by the Chairperson as the temporary authority is limited to the conditions of the existing licence and the legislation would only need to be amended to require Police approval to ensure the suitability of the applicant to hold a Temporary Authority.

The Act does not clearly identify time frames around the Hearing process.

#### SSAA Regulations 2013 – Forms, as noted by our Licensing Support Officer

- Form 9 (On-licence) has **still not yet** been amended to include reference to Easter Sunday under Condition (a).
- Forms 12 and 13 (special licences) of the Regulations still contain incorrect reference to sections of the Act. The correct reference should be <u>Subpart 7 of Part 2</u> which was confirmed by the Ministry of Justice shortly after the full SSAA came into force. Form 11 was subsequently amended on 11/12/15, but forms12 and 13 have not.
- There is an application form for a temporary authority (Form 16) but there is no regulation form for the actual "order".
- It would be helpful to have an area on all licence application forms under conditions asking the applicant to verbally identify the designations of the premises, and a description of each designation. It doesn't seem to matter how much information you give applicants,

they still do not know what designations are, particularly "supervised". We have added this to our application forms, and it has been very helpful.

5.0 Ways the Sale and Supply of Alcohol Act 2012 is achieving its object.

Licensees and managers alike are more aware of their obligations under the Act, and are more likely to discourage certain behaviours and enforce compliance due to penalties/fines they may receive under the Act.

6.0 Any other matter the TA might wish to draw to the attention of the Authority

It would be helpful if there was some avenue for Licensing support staff to request help/advice/opinions of other licensing admin staff or even inspectors. Under the new Act, some Administration Officers, particularly in smaller councils, have had to take on roles, and deal with both public and licensee enquiries, that previously an inspector would have dealt with. It is noted that the NZILLI listserve is a helpful tool for inspector's to glean information, however it would also be beneficial for Administration Officers being able to access, or have some other forum for communication.

7.0 Statistical Information

Territorial Authority statistical/fees return for applications received during the reporting year ending 30 June 2019, number of BDLC decisions made, and current listing of licensed premises is attached.
