Season's greetings – Mayor's message



Council has been very fortunate to have such a positive community that has achieved a great deal this year through the efforts of numerous volunteers.

The Sculpture Symposium, the floating pontoon at the lagoon, John Bougen's passion for Reefton working with the community to build on prior community work to embrace a large clean-up and create vibrance with a number of local volunteers, the new Granity School playground, the restoration work on the Lyric Theatre and the standout community

development of 2016 in my opinion – the development of the Kawatiri walkway/cycleway – Millennium Track. These are only a few of the numerous activities that reflect the adage *it is not just what the community can do for you, but what you can do for your community.*

2016 has been a year of change for Council. Elections have brought four new councillors to the table and retirements, along with promotions, have meant we have three new senior management personnel.

I know 2017 will be a year of key decisions. The Tai Poutini West Coast Growth Study will develop the 'action plan' and at that point we will have to make a commitment to projects that will have long term benefit for the Buller District and the West Coast. We need to acknowledge now that it will be at a cost, as it requires partnerships with Local Government, Central Government and private enterprise. Investment will be required to create a stronger economy which may take three to five years before the real benefits can be seen.

Key projects will include the Punakaiki Dolomite Point redevelopment, Karamea's limestone arches and the Westport to Charleston Kawatiri Trail. On the business front the development of EPIC Westport, Waste to Energy WC Ltd, Phoenix Coal (Stockton) and a number of smaller enterprises will impact on employment. Te Kuha-Rangitira Developments Ltd, decommissioning Holcim, and the factual

investigation of the Northern Link road proposal will have considerable implications on the more immediate and long term future for Buller.

In February 2017 the Local Government Commission will continue the work on determining the best governance structure for the West Coast including what efficiencies can be obtained while improving services throughout the Coast. The process will demand considerable time and good community engagement to gain benefit from this process.

Council will have an increased workload as it facilitates and works through the above along with 2015-2018 Long Term Plan commitments. These include the Westport Cultural Hub which potentially includes the Town Clock development, water projects, district plan review, the Reefton swimming pool and very careful consideration to the affordability in retaining the Kawatiri dredge. These can be contentious and it is essential that we have the very best information to make appropriate decisions.

Flood mitigation of Westport and coastal erosion that is affecting so many areas of our coastline and rural communities will require several community meetings as we work with West Coast Regional Council.

2017 will be a year where we must ensure a high level of community engagement and communication. Council, management team and the community will need to consider the immediate 10 and 50 year outcomes of decisions. It will be important to acknowledge the effect of making a decision and the consequences of not making a decision. At a recent training session we were encouraged to think of governance like driving a car, *spend most of your time looking ahead and a far smaller amount of your time looking in the rear view mirror.* It was noted that Council agendas dedicate most to compliance, looking in the rear view mirror. So there needs to be a balance between good accountability data and reporting that allows for planning ahead.

These are exciting times and we will need plenty of *Em's Power Cookies* to get through!

Launch of free wifi internet service

A free public internet service is being trialled at a few hotspots around Westport this summer. A number of towns around the country provide free internet in shopping areas to encourage visitors into the town centres. Council plans to expand this service to other locations around the district if the trial is successful.

Current hotspots are located outside the Coaltown i-Site, the garden seating area beside Subway, and the airport. The service is currently available from 7.00am to 9.00pm and is limited to one hour per day use with a data cap.

The ongoing viability of the service requires sponsorship and we hope that local businesses will get onboard with their support. Businesses who choose to become sponsors will have their logo appear on the splash page that all users go through when connecting, as well as the option of your logo appearing on a sign at a hotspot location.

Changes to public notification of alcohol licences

When an applicant applies for a new alcohol licence or to renew an existing licence they must publicly notify that they are applying and this has historically been by a notice published in the local newspaper. As from 1 January 2017, public notices will no longer be required to be advertised in the local newspapers but instead they will be published on Council's website for 15 working days. Many other New Zealand Councils have already changed to electronic notices via the internet and dispensed with the need for newspaper advertising. The Grey District Council and the Westland District Council have also chosen to adopt the electronic notice practice.

Public Notices

Ministry of Health

The Ministry of Health has asked Councils to remind residents that some plumbing fittings have the potential to allow minute traces of metals to accumulate in water standing in the fittings for several hours. Although the health risk is small, the Ministry of Health recommends that you flush a mugful of water from your drinking water tap each morning before use to remove any metals that may have leached from the plumbing fittings.

The Ministry of Health recommends this simple precaution to all households, including those on public and private water supplies.

Rural Town Water Supplies

The Buller District Council wishes to advise and/or remind all consumers on the rural town water supplies at Little Wanganui Subdivision, Mokihinui, Ngakawau/Hector, South Granity, Waimangaroa and Inangahua Junction, to boil all drinking water for at least three minutes.

These water supplies are untreated and originate from bush catchments where there is always a potential for the water to be contaminated from a variety of animal and bird life.

News from Animal Control

Unregistered dogs

There are currently 180 unregistered dogs in the Buller District. Council's Animal Control officers are following up with property visits to sight these dogs and speak with owners regarding their outstanding registration.

If you are the owner of an unregistered dog please come in or call us on 788 9111 to discuss registration, you could avoid getting a \$300 infringement.

Reminder

Dog owners are reminded that your dog is not allowed to foul any place or any land other than that occupied or owned by you. You must remove the faeces immediately and if you use a public litter bin or similar receptacle to dispose of the faeces, they must be suitably wrapped or contained to prevent the bin from being fouled. There has been an increased amount of faeces left around the Kawatiri Beach Reserve and River Trail. A new dispenser with bags has been installed for the purpose of keeping the area clean and tidy. Please be respectful and pick up after your dog, it is an offence not to pick it up.



Buller Beautification Awards 2017

It's that time of the year again to consider entering the annual Buller Beautification awards. Hopefully you have your summer garden planting underway.

The awards will be run in the same format as last time and are open to urban and rural properties, non-residential gardens, public spaces, and pensioner housing gardens. They were initiated by the Council some years ago to encourage residents to take pride in the appearance of their property. Judging is done from the street only, as the awards are all about what the residents or visitors can see as they pass by. People can nominate their own garden, or the gardens of others they think deserve recognition.

All nominees will be contacted to confirm that they are happy for their

garden to be entered prior to judging time.

Entry forms will be available from the Buller District Council offices in Westport and Reefton, Karamea Information & Resource Centre, selected retailers and can also be downloaded from Council's website www.bullerdc.govt.nz. Entries close Wednesday 18th January 2017.

The Westport and surrounding areas will be judged the first week of February 2017, however at the time of printing of the newsletter a date is yet to be confirmed for judging of the Reefton/Inangahua area.

So, if you have established a new garden within the last two years, made over an existing garden or generally have a well-kept and maintained garden, and you think it worthy of an award, we would love to have you enter.
