- ❖ *Location of any new generators, etc.*
- ❖ *Location and distances of new power/telephone pole(s) or lines to roads and any existing accesses.*
- ❖ *A copy of the Certificate of Title for the property that the lines / poles are to be installed.*
- ❖ *A deposit of \$500.00.*

*** Please note that this is a deposit only and Council operates on a full cost recovery system. Therefore if the cost of processing the consent is more than the deposit, you will be charged the additional amount. Upon payment of any additional amount, you will receive the consent.**

You must also include an affected persons consent form for any person whose land the line will cross. You may require consent from other people who Council considers may be affected. Please check with a Planning Officer prior to submitting this application.
