

Summer's coming

Time to check your swimming pool safety.

As the weather warms up, Council is reminding everyone to make sure their swimming pool or spa pool barriers meet the New Zealand Building Code's clause F9.

A 'pool' is any structure or excavation used for swimming, with water more than 400 mm deep.

The goal of clause F9 is simple to prevent young children from accessing pools unsupervised and keep them safe.

If you have a swimming pool or spa pool, you'll need to ensure it's:

- Registered with Council, unless it qualifies for a spa pool exemption under clause F9
- Compliant with the fencing or cover requirements

Even temporary or pop-up pools over 400 mm deep need to comply and be registered if they don't meet the exemption rules. Please let us know if you have a pool that's not currently on our register.

Property owners on the pool register will be contacted to arrange a pool barrier inspection to confirm everything meets safety standards.

Gambling venues

Council is seeking feedback from the community on its Draft **Gambling Venues Policy.**

Following on from earlier community engagement and consideration of a Social Impact Assessment, the draft policy sets out where and how venues can operate electronic gaming machines (pokies) and where standalone TAB venues can be located.

The draft policy keeps the requirement for any future applications for new venues or additional pokie machines to be publicly notified, allowing the community to make submissions, which Council will consider before making a decision on the application.
