Dog Control Act 1996

Section 52 provides for control of dogs:

- 1. The owner of any dog shall keep that dog under control at all times.
- 2. Without limiting the generality of subsection (1) of this section, a dog shall, for purposes of this Act, be deemed to be not under control:
 - a) If it is found at large on any land or premises other than a public place or private way without the consent (express or implied) of the occupier or person in charge of that land or those premises; or
 - b) If it is found at large in any public place or in any private way in contravention of any regulation or bylaw.
- 3. Where a dog is not under control in terms of subsection (2) of this section, the dog control officer or ranger may seize the dog and cause it to be returned to its owner or impounded.
- 4. Where, in the opinion of:
 - a) The occupier of any land or premises, or of any other person acting with the authority of such occupier (whether express or implied); or
 - b) Any person in any public place or in any private way, a dog is likely to cause annoyance or distress to any person or animal or damage to any property on the land or premises or in any public place or in any private way, the occupier or person may seize the dog and cause the dog to be returned to its owner, or to be delivered into the custody of a dog control officer or dog ranger.
- 5. Nothing in subsection (4) of this section authorises any person to seize any dog that is under the direct control of any other person.
- 6. Where a dog is, under subsection (4) of this section, delivered into the custody of a dog control officer or dog ranger, the dog control officer or dog ranger may cause the dog to be returned to its owner or impounded.
- 7. Nothing in this section shall authorise a dog control officer or dog ranger to enter upon any land or premises other than a public place or private way for the purposes of this section without the consent (express or implied) of the occupier or person for the time being in apparent charge of that land or those premises.

Section 54 provides for the obligations of dog owners:

- 1. The owner of any dog shall:
 - a) Ensure that the dog receives proper care and attention and is supplied with proper and sufficient food, water and shelter; and
 - b) Ensure that the dog receives adequate exercise.
- 2. Every person commits an offence and is liable on summary conviction to imprisonment for a term not exceeding 3 months or to a fine not exceeding \$5,000 who, being the owner of any dog, fails to comply with subsection (1) of this section.

PLEASE NOTE:

- All dog owners with dogs ordinarily kept in the Buller District that are over three (3) months of age must be registered with the Buller District Council. It is an offence to keep a dog older than three months, which is unregistered. Any dog over the age of three months found not wearing a collar with a current registration tag will until the contrary is proved, be treated as unregistered and may be seized and impounded.
- Replacement tags and collars may be obtained from the Buller District Council if the current tag or collar has been lost or stolen.
- All changes of address and ownership must be notified to Council within 14 days. It is an offence not to comply with this requirement.

All dogs registered in New Zealand for the first time from 1 July 2006, except working farm dogs, need to be microchipped.

This applies mainly to puppies and imported dogs. Most other dogs will not need to be microchipped unless they:

- Have been classified as dangerous or menacing on or after 1 December 2003.
- Are unregistered and get impounded
- Are registered and get impounded twice from 1 July 2006.
