Hi Pete,

Just reaching out again on the Punakaiki Wild project, now we have some further project information to share.

By way of project update, we have lodged the resource consent application with Buller District Council, with this currently in process. The project involves a luxury lodge (comprising a restaurant, bar and spa facility), 15 self-contained accommodation cabins, a worker accommodation building, a lodge support / utility building, along with associated access, parking, infrastructure and earthworks, and significant ecological restoration planting throughout the site. The application is supported by a draft 'Vegetation Management Plan' (see **attached**) that details the extent of both passive regeneration and active revegetation proposed, however we are advancing a consent condition that requires the preparation of an Ecological Enhancement Management Plan (prior to earthworks commencing), the objectives of which are:

- a. to detail the proposed vegetation management and planting outcomes across the site (i.e., active and passive regeneration areas, with this to be detailed in a vegetation management plan);
- b. to manage the effects of construction on indigenous vegetation; and
- c. to outline the details of the ecological enhancement works across the site, including plant management, pest management and staging outcomes.

The application is supported by a number of expert reports, notably a detailed ecological report and landscape assessment, with these documents including some detail around the proposed ecological plant list. We are also in the process of preparing a lighting design / management report, with this intended to minimise light spill and avoid adverse effects on wildlife (noting we're taking direction from some of the work undertaken for the Dolomite Point visitor centre).

Whilst the application has been lodged, we're keen for any feedback you (or the wider DOC team) may have so we can consider the same moving forward, noting we're still in the early days of the resource consent process. I'm happy to have a chat over the details, or forward through the resource consent documentation (or specific plans / reports?) for you to review and provide feedback on. Let me know.

Hope you're well.

Dan Benny from Buller DC passed on your details (before he left), so hopefully you're the right person within DOC to speak to regarding a development proposal we're looking at north of Punakaiki (have copied in the local office email just in case). My client has recently purchased the 20ha block of land at Perpendicular Point - the address is 4663 State Highway 6, Te Miko, Punakaiki (Valuation Ref: 18860/28400), and was previously owned by Graeme Smith. The property is directly to the north of reserve land associated with Paparoa National Park and the Truman Track, and has had a long history of stock grazing, scrub clearance and hobby farming.

My client has thus far acquired two rural properties in New Zealand, with the intention of partnering with an experienced luxury tourism operator to create a new brand of luxury, low density, eco friendly cabins and lodges. The particular concept for the 'Punakaiki Wild' site is to establish a luxury accommodation development comprising a restaurant and spa facility, along with approximately 20 small scale accommodation cabins (each around 36m2, self contained with solar). The concept is inspired by the natural landscape, with a key project component involving a significant ecological restoration element to create a 'wild' experience for guests and visitors. We've commissioned survey, geotechnical / coastal hazard, ecological, landscape and transportation advice, and are firming up the details of the project. At this stage (and subject to confirming travel logistics) we're looking at getting over to Westport 11 and 12 November, and thought it might be worthwhile to catch up and take you through the project – we should have a plan by then that details the restoration areas and details which we can share for your feedback. Let me know if this is of interest, and we can try and pin down a meeting date / time.
