We refer to your official information request dated 11 May for information regarding reserve contributions.

The information you have requested is below:

Reserve Contributions as at 30 June 2020 = \$1.215m.

The purpose of the reserve is "proceeds of subdivision for public reserve upgrades". It does not go toward footpaths, but can be used toward public reserve upgrades, it is proposed in the LTP \$896k would be spent on mainly beautification (gardens) tree replacement and playground safety and equipment over the 10 years of the plan.
